Public Entrance / Exit	Pushing.	Public	High	Organise a strict queuing system.
Emergency evacuation procedure	Loss of Power.	Public	Medium	Staff are trained to evacuate inflatables which will deflate slowly.
Very wet weather on the day	Slippery surface and Electrics.	Public	High	Inflatables are not used if wet. Bouncing area to be dried if a passing shower occurs then resume use.
Adverse weather and Weather Warnings	Do Not Use Inflatable.	Public	High	High winds, excessive heat and extreme cold.
Care of children	Accidents and Lost Children.	Public	Medium	Trained staff for equipment. Parents to remain present whilst children on inflatable.
Toilet provision	N/A	Public	Low	Use of public toilets.
First Aid	Accidents.	Public	Medium	Minor injuries dealt with by parents. In the case of major accidents call ambulance.
Litter	N/A	Public	Low	Staff clear the site after use.

Risk of fire	Generator overheating.	Public	Medium	Generator is kept 3m clear of the rear of the inflatables. Serviced regularly – PAT tested.
Crowd management	Overcrowding.	Public	Medium	Staff trained in handling crowds by maintaining queuing system.
Moving vehicles	Accidents.	Public	High	No vehicle movement whilst the inflatable is in operation. All other times 5mph with vehicle hazards lights on.
<b>ACTIVITIES:-</b>				
Inflatable use	Shoes.	Public	High	Ensure removal of all footwear / shoes before entering the inflatable.
Inflatable use	Keep helmets on when given for item. No Jumping or Somersaults.	Public	High	Only two people at a time.
Inflatable use	No Pushing, Jumping and Somersaults on slides.	Public	High	No pushing, jumping or somersaults permitted. One person at a time goes down. No congregating on the platform or at the bottom of the slide. Rules reminded on entry and staff supervising at all times.
Inflatable use	Feet First if using the slide.	Public	High	Always to be in the seated position and feet first. Rules reminded on entry & supervised by staff at all times.
Inflatable use	Always remain behind ball. No climbing, jumping or somersaults.	Public	Medium	Always remain behind the football shooter / kicker. No climbing, jumping or somersaults on the item.
Inflatable use	Overcrowding of equipment.	Public	High	Maximum number of people

				on each inflatable as recommended by safety standards.
Inflatable use	Glasses.	Public	Medium	Suggestion of removal of glasses.
Inflatable use	Age restrictions.	Public	High	Strict age group / size sorting. No adults to be allowed on inflatable at the same times as children.
